PART D: TERMS AND CONDITIONS

1. No Person will be issued a Refreshment Vehicle Park Permit without first obtaining a Refreshment Vehicle Business Licence and must participate in the Refreshment Vehicle Park Permit lottery process.
2. No Person may transfer a Refreshment Vehicle Park Permit to another Refreshment Vehicle operator.
3. A Refreshment Vehicle Park Permit will be issued upon receipt of a Commercial General Liability insurance certificate in the amount of \$2,000,000 per occurrence and endorsed to include the Town of Amherstburg as an additional insured.
4. All Refreshment Vehicle operators will leave the assigned location in a clean, litter-free, damage-free condition; non-compliance will result in a revocation of the Refreshment Vehicle Park Permit and will be repaired at the Refreshment Vehicle Owner's expense. Location does not include utility hook up (electrical or water).
5. All Refreshment Vehicle Park Permit holders are responsible to remove any refuse which results from the operation of the Refreshment Vehicle.
6. Permits are valid from 7a.m. until 11 p.m. daily, or until the time in which the park closes, whichever occurs first.

I have read and understand the terms and conditions pertaining to a Refreshment Vehicle Park Permit. On receiving the said Permit, I agree to comply with all the terms and conditions outlined, the By-laws of the Town of Amherstburg and regulations regarding such activity in accordance with the Statutes of Ontario. I understand that the Town of Amherstburg may revoke a permit under the powers conferred upon it by the Municipal Act, any other Act, and/or By-law of the Town of Amherstburg.
