Highlights from the October 14th, 2025 meeting of Council:

REPORT OUT FROM IN-CAMERA SESSION

Item - Legal Advice and Information Regarding Proposed DevelopmentCouncil received the matter for informational purposes.

Item B – Legal Advice and Information Regarding Policing Operational Services Provided to the Town of Amherstburg

Council directed Administration to send formal correspondence to the Town of LaSalle and the LaSalle Police Services Board to initiate further discussions regarding the provision of policing services to Amherstburg. Administration was also directed to continue reviewing alternative policing options, including the re-establishment of the Amherstburg Police Service and entering into a contract with the OPP.

Heritage Property Plaque Presentations

A Heritage Property Plaque was presented to recognize the Murray Smith Residence.

Certificate of Accessibility

The Mayor read a letter and presented a Certificate of Accessibility on behalf of Assisted Living Southwestern Ontario (ALSO), as part of the "Assisted Living Goes Out" (ALGO) initiative. This was in recognition of the Town of Amherstburg's efforts to champion accessibility, diversity, and equality within the community.

REPORTS

Simcoe Street and Meloche Road Intersection Improvements (724029) - Tender Results

Council rescinded a previous motion directing all surplus funds from the replacement of Culvert #45 and #77 be returned to the General Reserve Fund. Instead, Council approved reallocating \$52,363 of the \$187,200.41 surplus to the Simcoe Street and Meloche Road Intersection Improvement project, with the remaining \$134,837 returned to the General Reserve Fund. Council also authorized administration to enter into an agreement with Amico Infrastructures Inc. for \$210,499 (plus HST) to complete the intersection improvements, subject to technical and financial approvals.

Repeal By-law 2004-96

Council passed By-law 2025-067, repealing By-law 2004-96, which had authorized the execution of a Consent Agreement with Crumbles Muffins Inc.

Local Government Week 2025

Council received Administration's report for information outlining the Town of Amherstburg's public awareness campaign in recognition of Local Government Week. Celebrated annually across Ontario, Local Government Week highlights the vital role municipalities play in delivering services that impact daily life and promotes career and volunteer opportunities within the municipal sector.
