Subject: Annual Treasurer's Report – 2023 Council and Appointee Statement

on Remuneration and Expenses

#### 1. **RECOMMENDATION**:

It is recommended that:

 The report from the Treasurer dated March 22, 2024, regarding Annual Treasurer's Report – 2023 Council and Appointee Statement on Remuneration and Expenses BE RECEIVED for information.

#### 2. BACKGROUND:

Section 284 of the Municipal Act, 2001, indicates that the Treasurer of a municipality shall in each year on or before March 31, provide the Council of the municipality an itemized statement on remuneration and expense payments in the previous year to,

- (a) each member of council in respect of his or her services as a member of the council or any other body, including a local board, to which the member has been appointed by council or on which the member holds office by virtue of being a member of council:
- (b) each member of council in respect of his or her services as an officer or employee of the municipality or other body described in clause (a); and
- (c) each person, other than a member of council, appointed by the municipality to serve as a member of any body, including a local board, in respect of his or her services as a member of the body. 2001, c. 25, s. 284 (1).

Section 284 of the Municipal Act, 2001 also dictates as a mandatory item, that the statement shall identify the By-law under which the remuneration or expenses were authorized to be paid.

### 3. **DISCUSSION**:

This report for the year ended December 31, 2023 discloses funds paid to members of Council and to each person appointed by Council as remuneration and for expenses.

## 4. RISK ANALYSIS:

The Treasurer's Report is required by the Municipal Act; failure to provide an itemized statement of remuneration and expense payments for the 2023 year as required by section 284 would place the municipality in a state of non-compliance. Additionally, political risk exists if the disclosure requirement is not met.
